

SIMPLIFIED DEFINITIONS

- **Homicide:** The killing of one human being by another.
- **Forcible Rape:** The carnal knowledge of a person, forcibly and/or against that person's will; or not forcibly or against the person's will where the victim is incapable of giving consent.
- **Robbery:** The taking, or attempting to take, anything of value under confrontational circumstances from the control, custody, or care of another person by force or threat of force or violence and/or by putting the victim in fear of immediate harm.
- **Aggravated Assault:** Unlawful attack by one person upon another using a weapon.
- **Assault Offenses:** An unlawful attack by one person upon another.
- **Burglary:** The unlawful entry into a building or other structure with the intent to commit a felony or theft.
- **Larceny:** The unlawful taking, carrying, leading, or riding away of property from the possession, or constructive possession, of another person.
- **Motor Vehicle Theft:** The theft of a motor vehicle.
- **Arson:** To unlawfully and intentionally damage, or attempt to damage, any real or personal property by fire or incendiary device.\
- **Intimidation:** To unlawfully place another person in reasonable fear of bodily harm through the use of threatening words/or other conduct, but w/o displaying a weapon or subjecting the victim to actual physical attack.
